The Disclosure Authorization Form must be completed for all materials, e.g., abstracts, presentations, posters, or demonstrations. No presentations will be made, nor will any materials be published, without proper authorization.

The Security Services Department of MIT Lincoln Laboratory has been assigned responsibility for disclosure authorization procedures for the **2007 High Performance Embedded Computing (HPEC) Workshop**. Both DoD and Industrial Security Regulations require written authorization for oral presentations or publication of materials (Part II). Disclosure authorization is required for unclassified contractor materials/presentations relating to work done under DoD contracts (Part II).

The Disclosure Authorization Form consists of two parts:

Part I Basic presentation information to be completed by **ALL** presenters.

Part II This section is the disclosure authorization disclaimer. Authors should indicate the appropriate reason for not needing further approvals and include a signature. The form should then be completed by the certifying official and forwarded to the MIT Lincoln Laboratory address at the top of the form by the date listed below.

The Disclosure Authorization Form will satisfy the requirement for both the oral presentation and print/electronic publication. The approved signed form and the written materials or presentation must be received at MIT Lincoln Laboratory by **15 August 2007**. Due to the time required to receive approval, it is suggested that you submit your materials and Disclosure Authorization Form to the proper official in ample time so that sponsor approval can be obtained before the **15 August** deadline.

In order that there will be no misunderstanding, it is emphasized that disclosure authorization must be provided for all materials relating to work done under DoD contracts. The certifying official must in all cases be a U.S. Government employee representing the author's agency or the appropriate user agency.
