

INSTRUCTIONS FOR DISCLOSURE AUTHORIZATION FORM

The Disclosure Authorization Form must be completed and signed for all materials, e.g., abstracts, presentations, posters, or demonstrations. No presentations will be made, nor will any materials be published, at this MIT Lincoln Laboratory event without proper authorization on the Disclosure Authorization Form.

Whereas MIT Lincoln Laboratory has been assigned responsibility for disclosure authorization procedures for this MIT Lincoln Laboratory event. Both DoD and Industrial Security Regulations require written authorization for oral presentations or publication of all classified and unclassified materials relating to work done under DoD contracts (Part II). Export control regulations must be complied with.

The Disclosure Authorization Form consists of three parts:

Part I: Basic presentation information required.

Part II: A signature is required in this part of the form. Please read the three categories A, B, and C in order to determine which category is applicable to your materials being presented.

Category A pertains to all materials in the public domain, cleared by the cognizant U.S. Government department or agency without limiter or done under one or more of the following:

- No U.S. Government funding involved and no export control restrictions (International Traffic in Arms Regulations (ITAR) and Export Administration Regulations (EAR))
- University-performed fundamental research to include DoD 6.1 Funding
- Government employee performing work outside official duties and no export control restrictions (ITAR and EAR)
- Foreign Industry / Foreign University

Category B pertains to all unclassified materials **with limiter(s)**.

Category C pertains to all classified materials.

A signature in the appropriate category of the Disclosure Authorization Form implies that the materials identified in Part I have been approved for presentation at the

When a certifying official's signature is required, it must in all cases be a U.S. Government employee representing the author's agency or the appropriate user agency. Presenters will be held responsible for all materials presented.
